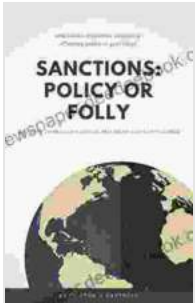

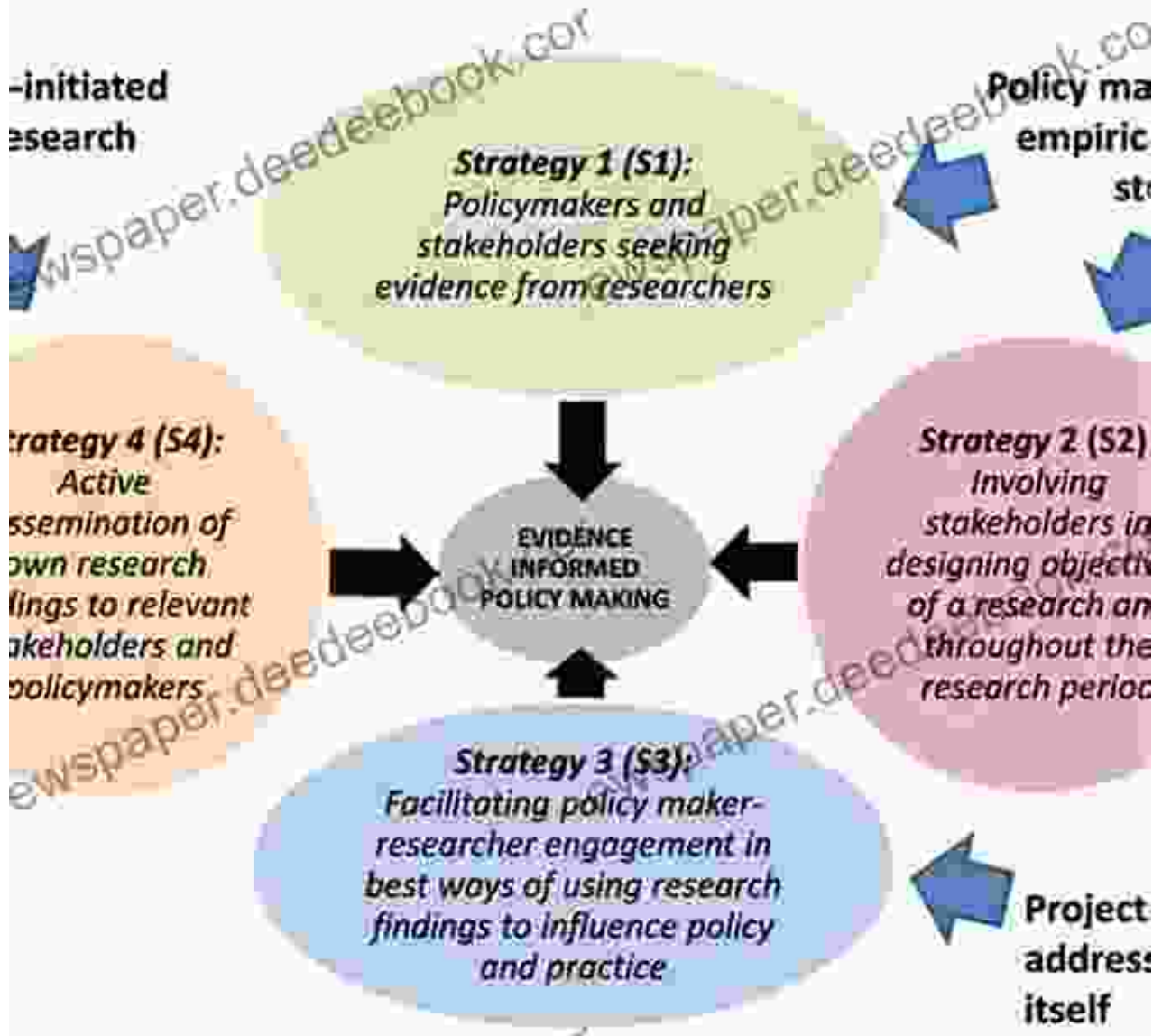

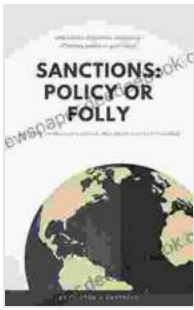
Barriers to Effective Communication

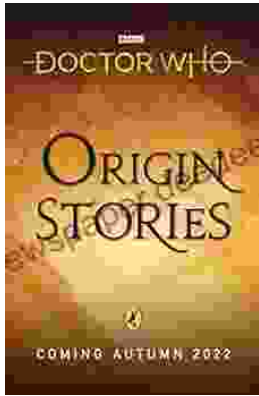
