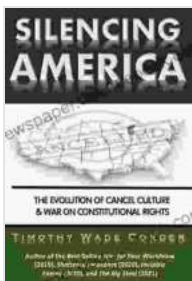


The Evolution of Cancel Culture: A War on Constitutional Rights

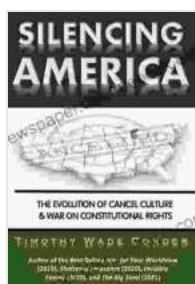

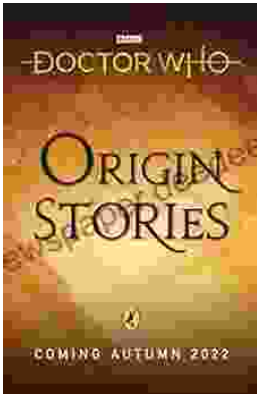
